You may access the Jangha Site ONLY for personal and non-commercial purposes.

Royalties Policy on Jangha

Jangha is created for musicians who want to share their art work with the world and it's royalties free. Within Jangha you can't collect royalties for the streaming or downloading of your own musical work of art so, if you are associated with Royalty collection societies such as (SIAE,ASCAP,GEMA,BMI,SACEM ecc...) you CANNOT upload your own musical work of art on Jangha, unless you have the permission or licenses that frees Jangha from paying royalties to your music.

In case of controversy Jangha with Royalty collection societies will suspend the account of

the musician.

It is very important for us (and also for yourself) that if you signed up with a collection society for music publishing you must request waivers and permission in order to free your royalties on the website [Http:\www.Jangha.com](http://www.Jangha.com).

By signing this contract you will be responsible for any uploaded musical work of art law violations .

Jangha for listeners

In order to listen and search musical work of art inside Jangha no account is required.

Users must create an account in order to:

- add music to favorites.
- make, save and share playlists .
- Rate a musical work of art.
- add simple comments.
- download musical work of art (when possible).

Creating account

In order to create an account Jangha will need this information :

- Name and Last name
- Birth date (must be older than 13, see Children's Online Privacy Protection Act of 1998)
- Country of origin and the name of the country where you live.
- Valid email address.

Creating Account

If you are a single musician or group of musicians and you have written and recorded any kind of musical work of art,

You can create a Music Account that will allow you to:

- Upload and Categorize your own musical work of art

- Make your musical work of art listenable (and if you want downloadable) to everybody.
- Create a page with your biography, discography, pictures, links (twitter, myspace, facebook, youtube, flickr)
- Tag similar artist and much more.....

When you create a Music account (single or bands) you will automatically create a cloned People account that you can use for (see paragraph "Jangha for Listeners").

Rules for musicians & bands

- Musicians must not have any contract with any record label .
- Musicians must not be associated with any organization for collecting royalties (such as ASCAP or BMI) .
- In case you have a contract with any label or any other musical organization, especially if you're member of (ASCAP, BMI, SIAE, Gema ecc....) you MUST request their permission (such as waivers, license ecc...) in order to subscribe yourself to Jangha.

In case of controversy with record labels, societies for collecting royalties or any other musical organization, Jangha will suspend the account of the musician.

In order to create a Music account for single musician we will need this information :

- Name and Last name.
- Birth date.
- Country of origin and the name of the country where you live.
- Valid email address.
- At least 1 musical work of art entirely produced by yourself.
- 1 image representing yourself
- Tags describing you as an artist.

In order to create a Music account for groups, bands or an ensemble of musicians you will

have to elect at least one member who will be the administrator :

- Name and Last name.
- Birth date.
- Country of origin and the name of the country where you live.
- Valid email address.
- At least 1 musical work of art entirely produced by band.
- 1 image representing band.
- Tags describing you as a band.

When you've finished the login operation you can invite others members of the band to sign in, just by inserting their email address.

The other members will receive a link by mail in which they can complete the login operation the same way.

Rules for uploaded musical works of art inside Jangha:

- Uploaded musical work must be entirely made produced by the owner or the owners of the Music account of Jangha.
- If you co-wrote your musical work of art you must have the permission of every person involved in the writing.
- Uploaded musical work of art must not be copyrighted or protected by Royalty collection societies.
- If your musical work is protected by Royalty collection societies such as(ASCAP, BMI, SIAE, Gema ecc....) you MUST HAVE their permission (such as waivers, license ecc...) in order to upload your musical work of art to Jangha.
- You can't upload cover songs.
- You can't upload remixed tracks.
- Only .mp3 extension
- We recommend to set the bit rate at 128 kbps of your .mp3

Policy Restriction on Lyrics

Jangha really believes in freedom and musical expression, so we don't have any restriction for your lyrics; but Jangha is against ignorance so, if your lyrics are about racism, pedophilia, violence or any form of senseless hate for religion or human organization, Jangha will suspend your account.

Indemnification

You are entirely responsible for maintaining the confidentiality of your password and account. furthermore, you are entirely responsible for any and all activities which occur under your account. you agree to indemnify, defend and hold harmless Jangha, its parents, affiliates and subsidiary companies, officers, directors, employees, consultants and agents from any and all third party claims, liability, damages and/or costs (including, but not limited to, attorneys fees) arising from your use of the Jangha site or services, your violation of these Terms and Conditions or your infringement, or infringement by any other user of your account, of any intellectual property or other right of any person or entity. you agree to immediately notify Jangha of any unauthorized use of your account or any other breach of security known to you.
